OPENING OF NEW ARMY SCHOOL IN 1993/

- 1. Reference para 5 of the Minutes of the AWES Board of Governors Meeting held at Army HQ on 12 Nov 92 and forwarded vide this HQ letter No E/42044/AWES/10-A/CW 4(a)-3 dated 20 Nov 92.
- 2. The following new Army Schools to be opened in 1993 have been approved:-
 - (a) HQ Southern Command Ehuj
 - (b) HQ Eastern Command -- Khaprail
 - (c) HQ Western Command Suratgarh
 - (d) HQ Central Command Danapur Cantt
 Dipatoli (Ranchi)
 Jabalpur Cantt
 Lansdowne
 - (e) HQ Northern Command Madhopur
- J. Please ensure that the above new Army Schools are opened with effect from 01 Apr 93. No request to delay the inauguration of the new School or its cancellation will be entertained. A confirmation to the effect that the new School(s) has/have been made functional from the academic year 1993-94 commencing 01 Apr 93 will be forwarded to this HQ latest by 15 Apr 93.
- 4. Information concerning the School as per proforma at Appx 'A' attached will be forwarded to reach this HQ by 15 Apr 93.
- 5. Corpus of & 5 lacs each to the new Schools will be released only after the receipt of the above confirmation. If the School is opened with atleast Class VI on ground and had amminimum strength of 20 children out of which 15 are of service personnel, then the School is authorised a Corpus of & 10 lacs. Prior intimation in respect of Schools are is being opened with atleast class VI on inception is required

to reach us by 15 Dec 92 so that the enhanced corpus due may be budgeted accordingly.

Army Schools are contained in our letter No B/42044/
AWES/18/CW-4(a)-3 dated 17 Sep 90. However, it is again intimated that the entire corpus given by Army HQ to Army Schools under your Command will be kept in fixed deposits with authorised Public Sector Undertakings to generate maximum interest. An Army School should aim to fully meet the salary bills of the school staff from the fees collected from the children plus the interest accruing from the Corpus given by Army HQ. No capital expenditure should be incurred from fees and the interest from the corpus. Capital purchases should be made only from the funds released by Headquarters Coamands concerned.

7. One copy each of the AWES Rules and Regulations for Army Schools for the guidance of the formation Headquarters controlling the newly raised Army Schools is being despatched to them. Two copies each of the AWES Rules and Regulations for Army Schools would be forwarded to the Principals of the concerned sanctioned schools when confirmation as asked for in para 3 above is received from them.

8. A new Army School will be designated as 'Army School' followed by the ame of the station as given in the Survey Report of the School. Article 232 of the AWES Rules and Regulations for Army Schools refers.
